

Iowa State Savings Bank MyPhoto Card • Terms and Conditions

Iowa State Savings Bank MyPhoto Card service is subject to these Terms and Conditions. The Image submitted by you is herein referred to as the “Image”.

1. You certify that you have read and understand the Image Guidelines and that the Image you submitted to Iowa State Savings Bank complies with the Image Guidelines.
2. You warrant to Iowa State Savings Bank that: 1. You are the owner of the Image (i.e. the Image was taken by you) or you have obtained express consent from the Image’s owner to use the Image on your MyPhoto Debit Card; 2. You obtained express consent from any person whose Image you use on your personalized check card; and 3. Use of the Image by Iowa State Savings Bank will not infringe any other person’s rights, including intellectual property rights, in the Image.
3. Iowa State Savings Bank may, in its discretion, require evidence of the Image owners consent or of your ownership of the image.
4. You grant to Iowa State Savings Bank a perpetual, non-transferable, non-exclusive, royalty-free, world-wide irrevocable license to use the Image and the data you provide to Iowa State Savings Bank for the purpose of providing your MyPhoto Debit Card.
5. You consent (or have obtained consent from the Image’s owner) to Iowa State Savings Bank storing, modifying, copying or using the Image.
6. You shall indemnify and hold harmless Iowa State Savings Bank, its successors and assigns, against any claims arising or loss suffered by Iowa State Savings Bank resulting from your use of this service or as a result of the Image being used on and reproduced on your MyPhoto Debit Card, or arising out of or as a result of Iowa State Savings Bank storing, modifying, copying or using the Image.
7. Iowa State Savings Bank’s liability hereunder is not liable to you for any loss, damage, claim or expense whatsoever in relation to any action by Iowa State Savings Bank permitted under these Terms and Conditions. Iowa State Savings Bank is not responsible for poor-quality Images or Images poorly positioned on the MyPhoto Debit Card template.
8. Your MyPhoto Debit Card remains the property of Iowa State Savings Bank and you agree to immediately return it or destroy if asked by Iowa State Savings Bank for any reason, or if the card or accounts that your MyPhoto Debit Card is linked to is/are closed.
9. If approved, the Image will be stored by Iowa State Savings Bank or its agents and contractors for a period of at least four (4) years. The Image will be printed on any subsequent reissued MyPhoto Debit Cards within a four-year period unless you have uploaded another Image within that period.
10. Iowa State Savings Bank reserves the right not to accept or use any Image you submit, or to refuse to issue a MyPhoto Debit Card for any reason.
